Petition From Residents to recommend Board of Selectman reconsider their yes vote for a horse race facility located at 228 Barre Road

Consideration and action on motion to reconsider vote to approve the location of a horse racetrack on Great Meadowbrook farm. Further, if not successful consideration a vote to call special election on January 7, 2023 pursuant to General Law Chapter 128A Section 13A will be require.

Cara Wilczynski, spokesperson for the group Hardwick Village for Responsible Growth, presented a petition for the selectmen to reconsider their vote.

Many comments about elections and the question posed of propenant to pay for special election. This is not appropriate to ask them to pay for this election. Board of Selectmen's options are as follows:

- 1. Do nothing, and leave vote as it stands from the November 9th meeting
- 2. Board decides to leave vote as is. Vote on special election would be on January 7, 2023 JQ had a recommendation to develop a 7 or 9 person committee as done in the past. Have public information sessions so everyone can have as much information as they need.
- 3. motion to reconsider and if the motion fails then we are with vote take on Nov 9, if passes vote is reconsidered.

JQ is concerned that there are many questions that need clarification. The Board can do things to get accurate info out to the town. Most of the question seem to be around the Host Community Agreement.
